1.	The solicitation of contributions was made under my responsibility only or through the persons I have designated in writing in accordance with the <i>Act respecting elections and referendums in municipalities</i> .
2.	All contributions collected have been made in accordance with the provisions of division VI.1 of chapter XIII of the Act.
3.	All sums collected for the leadership candidate have been deposited in the only campaign fund open for campaign purposes (section 499.5 and directive D-M-4.1) and comply with the <i>Act</i> .
4.	The loans obtained and the suretyships signed in connection therewith comply with the <i>Act</i> . In particular, when these loans are made by an elector, they have been paid by means of a personal cheque from the elector, voluntarily, without compensation or for no consideration, and they will not be subject to any reimbursement other than what is provided for in the loan agreement.
5.	All forms of cash inflows and disbursements were deposited or paid using the bank account indicated in this return.
6.	A contribution receipt was issued for any goods or services provided free of charge by an elector, with the exception of volunteer work.
7.	Individual who performed volunteer work within the meaning of section 499.8, which refers to section 428(1), during the period did so personally, voluntarily, and that work was carried out without compensation or for no consideration.
8.	All expenses incurred or authorized by me and for which I was given notice are included in the campaign income and expense return and have been incurred in accordance with the requirements of the <i>Act</i> . All claims received on or before the 60 th day after the day set for the poll have been paid, except those that I contested and reported.
9.	I have appointed the assistants pursuant to section 499.11, which refers to section 385, and all expenses authorized by them are included in the return, where applicable.
10.	All campaign expenses have been paid from the only campaign fund open for campaign purposes (section 499.5 and directive D-M-4.1), with the exception of the contested claims listed in this report.
11.	No campaign expenses were paid in cash, with the exception of those from the petty cash created from the campaign fund under the responsibility of the financial representative.
12.	All campaign expenses included in the return shall be supported by an invoice in compliance with section 499.11, which refers to section 466. These invoices present all goods supplied or services rendered.
13.	All campaign expenses were incurred at the current market price in accordance with section 499.8, which refers to section 427, and section 499.11, which refers to section 461. In addition, with the exception of volunteer work, an invoice certifying the value of any good or service provided free of charge by an elector is attached to the return.
14.	The information contained in this return is true, accurate and complete.
