

Reference: Act respecting elections and referendums in municipalities (s. 499.17)

PURPOSE

Prescribe the required form of the Complementary return of leadership campaign income and expenses of a party. The financial representative of a candidate must file such return when he or she has not paid all claims (invoices) received and when he or she has not repaid all loans contracted as of the date the return of leadership campaign income and expenses was filed.

CONTENT

Using the form Complementary return of leadership campaign income and expenses of a party is mandatory.

Sections 1 to 5 must be completed by the financial representative of the candidate and attach them to this report, as explained in the template appended to this directive.

The sections « Signature and declaration of a financial representative » and « Signature and Declaration of a party leadership candidate » must be signed in order for the Complementary return of leadership campaign income and expenses to be accepted.

PERIOD COVERED BY THE REPORT

The financial representative of the candidate must file a report every three months following the filing date of the candidate's return of campaign revenues and expenses, until all claims received and loans contracted are paid in full, or until the expiry of the applicable time limit under sections 499.14 and 499.15 of the *Act*.

Any complementary return filed under section 499.17 shall cover a period of three months. The start date always corresponds to the day after the end date of the latest return filed.

This return should only include collected revenues and repayments applied to campaign debts during that three-month period, where applicable.
