

How to complete the application for authorization of a private intervenor **Elector**

A. Mandatory information

An elector who asks to act as a private intervenor must provide the returning officer of his electoral division with the information stipulated in section 457.3 of the *Election Act*.

Line 1:

Enter your name and date of birth.

Line 2:

Enter the address of your domicile and your telephone number.

Line 3:

Indicate the purpose of your application for authorization by specifying, where applicable, the matter of public interest about which you wish to express your views.

B. Sworn declaration by the elector

You must sign this section and ask a person authorized to administer oaths to sign it as well. Anyone who is authorized to do so by a Quebec law (for example, a commissioner for oaths, a lawyer or a notary) may receive an oath under the *Courts of Justice Act* (RLRQ, c. T-16). The returning officer of the electoral division who receives the authorization request, an assistant returning officer and any other member of the election staff may also receive this oath, with the exception of the information and law enforcement officer, under the *Election Act* (RLRQ, c. E-3.3).

C. Attestation of this application for authorization

The returning officer of your electoral division must complete this section. Make careful note of the authorization number that will be assigned to you (000-000) as this number must appear on all your publicity.
