

## DIRECTIVE D-S-12

# Report of expenses of a private intervenor

Reference: Act respecting school elections to elect certain members of the boards of directors of English-language school service centres, sections 206.45 and 209.23

### **PURPOSE**

This directive prescribes the form for filing the report of expenses of a private intervenor.

## CONTENT

The private intervenor who is an elector or the person representing a private intervenor must, within 30 days after polling day, report all expenses to the returning officer using the prescribed form: *Report of expenses of a private intervenor* (DGE-5834).

#### **SWORN DECLARATION**

The return must include a sworn declaration. Under the *Courts of Justice Act*, such an oath can be administered by any person authorized to do so by a Québec statute (commissioner of oaths, lawyer, notary, etc.). The returning officer of the English school board may also administer the oath.

The private intervenor must attach invoices, receipts and all other required supporting documents to his or her report. He or she should also retain a copy of the report, including all attached documents, before sending it to the returning officer of the English school board.
