

Guide for completing the application for authorization of a private intervenor **Elector**

An elector who requests to be authorized as a private intervenor must provide the returning officer of his English school board service centre with the information stipulated in section 209.10.

A. OBLIGATORY INFORMATION

Enter in this section your personal contact information as well as the purpose of your application for authorization either by marking the box "Advocate abstention or the spoiling of ballots" or by marking the box "Publicize or obtain support on a matter of public interest". In this case, you must specify the matter of public interest.


B. SWORN DECLARATION BY THE ELECTOR

This section specifies the requirements of the *Act*, the oath and the elector's commitment.

Anyone who is authorized to do so by a Quebec law (for example, a commissioner for oaths, a lawyer or a notary) may receive an oath under the *Courts of Justice Act* (RLRQ, c. T-16). The returning officer of the English school board who receives the authorization request, the election secretary and any other member of the election staff may also receive this oath, under the *Act respecting school elections to elect certain members of the boards of directors of English-language school service centres* (RLRQ, c. E-2.3).

C. ATTESTATION OF THE APPLICATION FOR AUTHORIZATION

Leave this section blank. It is reserved for the returning officer of your English school board. Please make careful note of the authorization number that will be assigned to you (SCH00L-00) as this number must appear on all your publicity.
