

### Reports from an authorized candidate

Reference: Act respecting school elections to elect certain members of the boards of directors of English-language school service centres, sections 209, 209.1 and 209.4

#### **PURPOSE**

This directive prescribes the use of the form titled Reports from an authorized candidate.

#### CONTENT

An authorized candidate's financial report and return of election expenses must be produced using form DGE-5800, titled *Reports from an authorized candidate*.

This form will not be accepted unless the "Declaration of the authorized candidate" section has been signed.

If, after these reports are filed, debts arising from election expenses remain or the authorized candidate continues to hold money and goods derived from the election fund, he or she will be required to file an additional financial report in accordance with the directive D-S-5 and sections 209 and 209.3 of the Act respecting school elections to elect certain members of the boards of directors of English-language school service centres, CQLR, c. E-2.3 (ASEESSC).

### DOCUMENTS THAT MUST ACCOMPANY THE REPORT

This report must be accompanied by the supporting documents referred to in section 4.5 of the *Guide for the authorized candidate*.


